Application Procedure for Tourist Visa Myanmar

Here you find the step-by-step guide to apply for an entry visa for Myanmar. And what to do after it has been approved.

### 1. Submitting the application

Simply fill in the Visa Application Form (**see page 3**) and send as an attachment via email to Green Wood Travel. (This way you also must keep 1 copy).

2. Further communication will be done by email. It is very important to include your working email address.

3. **If approved**, Green Wood Travel will send you the "Approval Visa-on-Arrival Letter" via email.

4. You can show this (printed) Letter of Approval (mostly in Burmese) to the airline check-in counter at Bangkok International Airport. Note: if there is any problem, you can ask the staff to check with the supervisor and computer records. Normally we send the same approval letter to all airlines at the same time that they are being sent to clients.

5. In Myanmar you must produce at Yangon airport two copies of this "Approval Visa-on-Arrival Letter" to immigration officials along with 2 colour passport photos not older than 6 months and two filled in copies of the Visa Application Form (see under 1).

Visa On Arrival Fee: **60 USD** per person in total. You pay 30 USD at Yangon Airport and 30 USD to Green Wood Travel. Single traveller surcharge is **25 USD**. **\* There are no extra charges for Visa On Arrival.**

## MYANMAR VISA UPON ARRIVAL RULES!

Dear Green Wood Travel client,

We need the following information to apply for a Visa-on-Arrival. Please send full information as soon as possible.

\*\*\* Required in order to process the visa in time. **We need to have the information below at least 21 days prior to arrival.**

### ***The information required:***

- 1) Copy of client's passport with photo and personal details page (please scan original passport)
- 2) Client's name
- 3) Sex
- 4) Nationality
- 5) Ethnic background of client (e.g., Dutch, Belgium, Spanish etc)
- 6) Religion
- 7) Passport number
- 8) Date of issue of passport
- 9) Date of Birth
- 10) Place of Birth
- 11) Client's occupation
- 12) Client's permanent address
- 13) Arrival day to Yangon
- 14) Arrival flight detail

The application has to be approved by the deputy minister of the Ministry of Hotels and Tourism first. Then it will be submitted to the Visa-on-arrival-preliminary-approval Board. The Board holds its meeting twice a week (Tues-& Friday) to check and approve applications. Once the board approves we will inform the airlines and send the approval letter to our clients.\*\*\*

Don't forget to bring **TWO copies of Visa-on-Arrival approval letter** and also **TWO colour passport photos not older than 6 months.**

**Visa costs are 30 USD pp** (pay at Yangon airport), **service cost 30 USD pp** (pay to Green Wood Travel.)  
Single surcharge: **25 USD pp.**

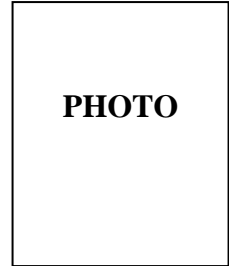
